
# **2025 Goat Project**

#### **Important to Remember:**

• Goat Registration Forms must be submitted in person to the MSU Extension Office located at 1715 Lansing Ave, Ste 257, Jackson, MI 49202 by Friday, May 2nd. To accommodate this, the office will have extended hours that week.

On Wednesday, April 30th, Thursday, May 1st, and Friday, May 2nd, the office will be open from 7:30 AM to 5:30 PM without a lunch closure. However, on Monday and Tuesday of that week, the office will operate during regular hours, from 8:00 AM to 5:00 PM, closed for lunch from 12:30 PM to 1:30 PM.

• They must be turned in by Friday May 2<sup>nd</sup> at the Extension Office.

This form is required by the Goat superintendents and is in addition to your fair entry form. Please contact the Goat Superintendents if you have any questions about the form or are unable to turn your forms in by May 2<sup>nd</sup>.

- There is a \$5 per 4H member participant fee per small animal species. The \$5 participant fee is due to the Goat Superintendents at check in.
- Record Book Project is due at check in. The project requires members to write at least two paragraphs answering several questions about their goat project.
- Your goat <u>must have</u> one of the following types of identification to be allowed at fair:
  - 1. United States Department of Agriculture (USDA) goat scrapie tag attached to their ear.
  - 2. Registered breeding stock may have an official breed registration tattoo in their ear. A copy of the registration certificate listing the tattoo must accompany the goat to fair. Tattoo must be legible at check in.
  - 3. For Non-Registered goats with no ears or injured ears (ex LaMancha), the scrapie tag must be attached to an adjustable collar to be worn at all times at fair. A tail flap tattoo will not be accepted for id.
  - 4. Breeds that allow it, (ex pygmy) can be microchipped but must carry the registration papers with the goat and provide a microchip reader.
    - All market wethers must have a scrapie tag in their ear or a tag attached to a collar.
    - All imported goats must meet the above identification rules and have an Interstate Certificate of Veterinary Inspection (CVI) from the state of origin. The CVI must include the results of a negative brucellosis test for goats six months or older, except wethers.
    - All goats **without** proper scrapie tags or tattoo with paperwork will be sent home. Contact Superintendents prior to fair for assistance.

#### **General Information:**

• All goat kids born for the 2025 Fair need to be born by April 1st. This applies to all breeds and includes does and wethers. Possession date for all goats is May 1st.

- Are allowed to bring up to 4 goats total to the fair and it is 1 goat per class.
- Fair entry forms are due to the Fair Office in June and **are required** to be able to show at the fair.

#### <u>PreFair:</u>

- Barn Cleanup day is the Sunday July 27<sup>th</sup> starting at 10 am.
- No bedding or decorations can be put in barn prior to the Thursday before fair.

# Check In:

- Check In is on Saturday from 10:30 am to 12:30 pm.
- **<u>Do not</u>** unload your goats before your goats are checked by the Superintendent.
- Your goat <u>must have</u> one of the following types of identification to be allowed at fair:
  - 1. United States Department of Agriculture (USDA) goat scrapie tag attached to their ear.
  - 2. Registered breeding stock may have an official breed registration tattoo in their ear. A copy of the registration certificate listing the tattoo must accompany the goat to fair. Tattoo must be legible at check in.
  - 3. For Non-Registered goats with no ears or injured ears (ex LaMancha), the scrapie tag must be attached to an adjustable collar to be worn at all times at fair. A tail flap tattoo will not be accepted for id.
  - 4. Breeds that allow it, (ex pygmy) can be microchipped but must carry the registration papers with the goat and provide a microchip reader.
    - All market wethers must have a scrapie tag in their ear or a tag attached to a collar.
    - All imported goats must meet the above identification rules and have an Interstate Certificate of Veterinary Inspection (CVI) from the state of origin. The CVI must include the results of a negative brucellosis test for goats six months or older, except wethers.
    - All goats **without** proper scrapie tags or tattoo with paperwork will be sent home. Contact Superintendents prior to fair for assistance.
- After check in **no** animals are allowed out of their pens on Saturday.
- Sign up sheets for Barn Duty (required for everyone) and Showmanship will be posted in the barn.

## <u>Fair Week:</u>

- Pens must be cleaned completely <u>every day</u> before 10am. Spot clean and check water during the day. Adding lime to your pen is highly recommended.
- No alterations or changes to goat pens or pen assignments without superintendent's permission.
- No animals are allowed out of pens after 11am without Superintendents permission and can only be walked in areas designated by the Goat Superintendents.

- No administrating of medication without Superintendents permission.
- A 2 hour Barn Duty shift is required by everyone.

#### **Goat Show:**

- Goat Show starts at 8:30am on Wednesday in the show arena next to the goat barn.
- Proper show and showmanship attire must be worn or you will not be allowed to show.

Boer showmanship: western style allowed with long or short sleeve plaid shirt and jeans.

Dairy and Pygmy showmanship: Black, white, or khaki pants and a plain white long or short sleeve shirt (A small emblem such as a 4-H logo is acceptable).

No shorts, tank tops, sleeveless shirts, or muscle shirts. Regular shoes or tennis shoes (no sandals, open toed shoes, or rubber boots). No excessive make-up or jewelry is allowed. Clothing must be clean and neat.

Must stay in the same clothes for the entire show.

#### **Checkout:**

- Decorations can be taken down Saturday from 10pm to 11pm, if desired or Sunday from 9am to 11am. No decorations can be removed before 10pm on Saturday.
- Goat checkout is Sunday **only** from 9am until 11am. All pens must be cleaned by 11am on Sunday.

# **Goat Information**

#### **General Rules:**

- 1. Goats must be born by April 1<sup>st</sup> and Possession Date is May 1st
- 2. Goat ID Forms due in person to Goat Superintendents at the Extension Office on Saturday May 3rd
- 3. Can take up to 4 goats, but they must be in different classes.
- 4. Breeding stock may show with or without horns if breed standard allows (Angora, Pygmy, and Boer/Meat breeds). Boer wethers may show with or without horns. All Dairy breeds must be dehorned.
- 5. Can only sell 2 goats at the auction.
- 6. Goats in the Dam and Daughter class must be owned and shown by same exhibitor.
- 7. Goats in the Costume Class, Homegrown class or Dam & Daughter classes must also be registered and shown in their individual classes.

# **Dairy Does:**

- 1. Any age
- 2. If registered in a milking class, Dairy does must be milking at fair
- 3. Have added a Dry Doe class this year for dairy does over 2 years old who are not milking
- 4. Breed examples Alpine, Nubian, La Mancha, Oberhasli, Saanan, Toggenburg, Nigerian Dwarf or crosses of above.

#### **Dairy Wethers:**

- 1. Born after December 1<sup>st</sup>, 2024
- 2. Breed examples Alpine, Nubian, La Mancha, Oberhasli, Saanan, Toggenburg, Nigerian Dwarf or crosses of above.
- 3. Market Wethers must be sold at auction.
- 4. Nigerian Dwarf wethers are shown under hobby class, do not have to be sold at auction, and are no longer required to show in costume.
- 5. Can be shown in Costume class, but also must be registered in individual class.

## **Boer/Meat Does:**

- 1. Any age
- 2. Older classes do not have to be milking
- 3. Breed examples Boer, Kiko, Spanish, crosses of these three, or meat/dairy cross
- 4. Can have horns

#### **Boer/Meat Wethers:**

- 1. Born after December 1<sup>st</sup>, 2024
- 2. Breed examples Boer, Kiko, Spanish, Myotonic, Savannah, crosses of above, or meat/dairy cross
- 3. Can be shown with or without horns
- 4. Wethers must be sold at auction
- 5. Can show in Costume class, but also must be registered in market class.

#### Pygmy Does:

- 1. Any age
- 2. Do not have to be milking
- 3. Can have horns

#### **Pygmy Wethers:**

- 1. Any age
- 2. Do not have to be sold at auction

- 3. Are shown with Nigerian Dwarf wethers in the hobby class
- 4. Costumes no longer required to show

## Fiber Breed Goats (Angora, Cashmere, Pygora, etc):

- 1. Does and Wethers do not have to be sold at auction
- 2. Can have horns.
- 3. Does and wethers show against each other

# **Hobby Wether Class**:

- 1. Pygmy/Pygmy Cross wethers and Nigerian/Nigerian Cross wethers **ONLY**.
- 2. Any Age
- 3. Do not have to be sold at auction.
- 4. **Costumes are no longer required.** If would like to show in a costume, they should also be registered in the separate costume class.

- 9) Hobby Wether
- 10) Boer Goats and Boer Crossbreeds including Boer/Dairy crossbreeds

#### **Classes for Breeds 1-7**

- Class: 75. Spring Doe Kid (born January 15, 2025 to April 1, 2025)
- Class: 76. Junior Yearling Doe (born October 1, 2024 to January 14, 2025)
- Class: 77. Dry Doe Yearling (born before October 1, 2024 but under 2 years)
- Class: 78. Dry Doe (over 2 years)
- Class: 79. Yearling Milker (1 year but under 2 years)
- Class: 80. Junior Milker (2 years but under 3 years)
- Class: 81. Senior Milker (3 years and older)
- Class: 82. Dam and Daughter (must be owned and shown by same exhibitor, and registered and shown in individual classes)
- Class: 83. Costume Class (must be registered and shown in individual class, may be doe or wether)
- Class: 84. Homegrown Dairy Market Wether (must also be registered in regular dairy market wether class)
- Class: 85. Dairy Market Wether (born after December 1<sup>st</sup> of fair year and Full Blood Dairy Breeds Only. Must be sold at auction).

#### **Breed 8 Pygmy or Fiber Breeds (Angora, Cashmere, Pygora, etc.)**

Class: 86. Spring Doe Kid (Born after January 1<sup>st</sup> this year)

Class: 87. Yearling doe (1 year but under 2 years)

- Class: 88. Junior Doe (2 years but under 3 years)
- Class: 89. Senior doe (3 years and older)
- Class: 90. Dam and Daughter (must be owned and shown by same exhibitor, and registered and shown in individual classes)
- Class: 91. Fiber Breed Wether
- Class: 92. Costume Class (must be registered and shown in individual class, may be doe or wether)

#### **Breed 9 Hobby Wether**

Class: 93. Hobby Wether Class: Pygmy/Pygmy Cross wethers, Nigerian/Nigerian Cross wethers ONLY. Do not have to be sold.

#### **Breed 10 Boer/Meat Goats and Boer/Meat Crossbreeds**

Class: 94. Spring Doe Kid (born January 15, 2025 to April 1, 2025)

- Class: 95. Junior Yearling Doe (born October 1, 2024 to January 14, 2025)
- Class: 96. Yearling Doe (born before October 1, 2024 but under 2 years)
- Class: 97. Junior Doe (2 years but under 3 years)
- Class: 98. Senior Doe (3 years and older)
- Class: 99. Dam and Daughter (must be owned and shown by same exhibitor, and registered and shown in individual classes)
- Class: 100. Costume Class (must be registered and shown in individual class, may be doe or wether)

Class: 101. Homegrown Boer & Boer Cross Market Wether (must also be registered in regular market wether class)

Class: 102. Boer/Meat & Boer/Meat Cross Market Wether (born after December 1<sup>st</sup> of fair year and must be sold).



For your goat project you are required to answer at least one of the following questions listed below.

Your answer should be a <u>minimum of two paragraphs</u> and either typed or handwritten on an 8  $\frac{1}{2} \times 11$  sheet of paper.

Make sure to <u>include your name</u> on the paper. You can also attach a photo of your goat if you choose.

Your paper is due at Check in on Saturday and we will be displaying them in the barn. Any questions, please contact the Goat Superintendents.
