ASSUMPTION OF RISK AND WAIVER OF LIABILITY

("Event"), I understand and agree to the following.

1. I represent that I (or my minor child) are in good health and in proper physical condition to participate in the Event(s), and I am not and will not be under the influence of alcohol or any illicit drugs or prescription drugs which would in any way impair my ability to safely participate in the Event(s).
2. I understand and acknowledge the physical and mental rigors associated with the Event(s) and realize that participation in this Event may involve risks and dangers which include, without limitations, the potential for serious bodily injury, permanent disability, paralysis, and death; loss or damage to property; exposure to extreme conditions and circumstances; accidents; illness,; contact or collision with other participants, spectators; vehicles or other natural or manmade objects; dangers arising from adverse weather conditions; imperfect course conditions; water, road, and surface hazards; equipment failure; inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the Event Organizer and other undefined harm or damage which may not be readily foreseeable, and other presently unknown risks and dangers. I understand that these risks may be cause in whole or in part by my own actions or inactions, the actions or inactions of others participating in the Event, or the acts or inactions, or negligence of the Event Organizer, and I hereby expressly assume all such risks and responsibility for any damages, liabilities, losses or expenses which I may incur as a result of any participation in the Event.
3. For myself and on behalf of my spouse, children, parent, guardians, heirs, and any legal and personal representatives, executors, administrators, successors, assigns, and agents, I hereby agree to fully release the Event Organizers, its officers, agents, representatives, employees, manager, and contractors from any and all liabilities, claims, or causes of action arising from or connected to my participation in the Event.
4. I certify that I have read this Agreement carefully and understand its contents.
5. I have signed this agreement freely and voluntarily, without any inducement, and intend for my signature to serve as confirmation of my complete and unconditional acceptance of its terms.
6. If any provision of this agreement is held to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and will not affect the validity and enforceability of any remaining provisions.
7. Photo release: Participants at the Menominee County Fair are sometimes photographed or videotaped for the use in Menominee County Fair promotional and educational materials. I authorize the Menominee County Fair to record, photography the image and or voice of myself or my child. I understand and agree that these audios, video, film and/or images may be edited, duplicated, distributed, reproduced, broadcast and or reformatted in any form and manner without payment of fees, in perpetuity.
