### Requirements/Information

- 1) All campers must be 4-H age 8-19 and enrolled in 4-H by 6/1 at <https://v2.4honline.com/>
- 2) \$225 camp registration includes classes, stall, breakfast, lunch, dinner, water/snacks each day and DOES NOT include camping/lodging. (Fee increases to \$250 after April 14<sup>th</sup> and to \$275 after June 1<sup>st</sup>. Registration will not be submitted without full payment.)
- 2) Overnight housing is the responsibility of participant's family. Camping is available for \$30/night and requires a separate registration form. A parent or guardian must be with any youth participant between 6:30PM and 7:30AM in the camping/horse areas. Horse Camp coordinators will not be responsible for any youth participant after dinner ends at 6:30PM and before 7:30AM.
- 3) **Refunds will only be issued if requested prior to 5/31.**
- 4) **Mandatory meeting Sunday, 6/22 at 9pm in Springfield Oaks Activity Center.**
- 5) Campers provide project horse (with proof of negative Coggins test), feed, bedding, & tack.

6) Campers must wear appropriate riding clothing, boots, and SEI helmet.
