4. Improve your management practices.
5. To develop integrity, sportsmanship, and cooperation.
6. To develop leadership abilities, build character, and assume citizenship responsibilities.
7. To keep track of your project activities and learning experiences.
8. To allow you to better plan for future livestock projects.
